IRS Gives Tax Deduction For Sex Change Operations!

The IRS is collaborating with mental illness by allowing this policy to stand.

The Massachusetts-based [Gay & Lesbian Advocates & Defenders \(GLAD\)](#) has recently won a complaint against the IRS over tax deductions for so-called “sex change” operations. The IRS apparently bought GLAD’s bogus argument that sex changes are medically necessary for individuals suffering from [Gender Dysphoria](#) (a mental condition where a person feels like he or she is the opposite sex).

The IRS has given the homosexual/transgender activist movement a key victory, but it is my hope that this victory will be very short lived.

The homo/trans movement is currently guided by a belief that concepts such as male and female are simply cultural inventions that can be altered at will by the individual. In 1993, [a transgender legal group](#) issued the “International Gender Bill of Rights,” that declares: “It is fundamental that individuals have the right to define, and to redefine as their lives unfold, their own gender identity, without regard to chromosome sex, genitalia, assigned birth sex, or initial gender role.” This is a sure recipe for sexual confusion and life-long despair.

By giving tax deductions for unneeded “sex change” operations, the IRS is aiding in the homo-trans effort to undermine the biological realities of male and female. The simple fact is that no one can change sexes. A male who has his sex organs removed and takes hormones for breast enhancement is still genetically a male—not a woman. This is an unchangeable reality. A man can no more become a woman than he can become a Dodge Minivan. A person who thinks otherwise is delusional—and needs professional care.

An individual who suffers from Gender Dysphoria has a serious mental problem—and this cannot be fixed by hormone injections and the mutilation of a person’s body. He needs long-term, intensive therapy, not mutilation.

The IRS is collaborating with madness by giving tax deductions for unneeded “sex change” operations. **The IRS policy should be reversed immediately.** And, the lunacy advocated by groups like GLAD should be aggress-

sively opposed in the courts and in the court of public opinion. We have no social obligation to normalize a mental illness.

Dr. John Money Pioneered Sex Change Ops.

Gender Dysphoria (a Gender Identity Disorder), is a condition where an individual believes he or she is the opposite sex.

Johns Hopkins University became one of the pioneers in sex change operations under the leadership of Dr. John Money. One of Money’s tragic experiments with a young boy is described in [As Nature Made Him: The Boy Who Was Raised As A Girl](#), by John Colapinto. This book details the life of David Reimer, who was raised as a girl after a botched circumcision left his male genitals mutilated. Reimer was a twin boy and Dr. Money convinced his parents to allow him to surgically alter their infant to raise him as a girl.

Dr. Money became an international celebrity as a result of this case and was hailed as a pioneer of successful sexual reassignment surgery.

The truth, however, was completely different than what Money had claimed in his research on David Reimer and his brother. Colapinto’s book describes the misery that David faced throughout his life. He never conformed to his role as a “girl” because he wasn’t one. And, when he was in his late teens, he learned the truth about himself and immediately rejected the female role that had been imposed on him by Dr. Money. He gradually went off hormones and assumed his birth sex.

Regrettably, however, David Reimer could never overcome his troubled past as a girl and committed suicide in the spring of 2004. (His twin brother Brian died of a drug overdose in 2002.)
